5. Hear update on Penn Park Pool and Boat Dock Park

Mr. Barnes provided the following updates:

• Penn Park Pool: Pool house building is 80% complete, infrastructure is nearing completion, and the parking lot is completed. The new pool sub-contractor began three weeks ago and anticipates a completion in early January 2023.

• Boat Dock Park: 90% of the bid documents are completed with the remaining portion to be completed from the landscape architect. The project is anticipated to bid before the end of 2022. Once construction begins, Boat Dock Park will not be open to the public.

- Chautauqua Celebration: The event partnered with the Cowboy Poets and was very successful.
- Stampede of Speed: This was the second year to partner with the Texas Motorplex for this event and it was a success.

Mr. Barnes provided an update on the following upcoming events:

- Christmas Parade and Tree Lighting: The lighted parade will take place on Tuesday, November 29th at 6:30 p.m. and will begin at Getzendaner Park and end at Railyard Park.
- Christmas decorations: Christmas decorations will begin soon with the Parks Department decorating City Hall, downtown Waxahachie, Railyard Park, Getzendaner Park, and Chapman Park.

Council Member Travis Smith inquired about adding bleachers downtown during the parade to assist spectators. The Board also discussed a special viewing area for Board/Commission member volunteers during the parade.
