# 4. Hear update on Cemetery plot sales and services

- March 4 plot sales and 7 burials.

#### 5. Hear update on dumpster enclosure

Mr. Barnes shared with the Board about the dumpster enclosure project and stated work has been completed by BBC Construction.

Chairman McGuire suggested putting landscaping around the dumpster enclosure. Mr. Barnes stated staff will look into it.

Ms. Marion Reynolds asked for Addition 11 parking area to be looked into for renovations. Mr. Barnes stated this will be included in the next Cemetery Board meeting as an agenda item.

# 6. Hear update on Headstone Restoration Project

Mr. Barnes shared that the Headstone Restoration Project is almost complete. There were 97 total headstones that were needing repairs. Out if the 97 headstones, 95 of them have been repaired and only two are left pending repair.

Ms. Reynolds asked for an update on installing cameras. Mr. Barnes stated that the IT department is working on installing cameras at the cemetery.

# 7. Hear update on Baby Land Headstone Project

Mr. Barnes updated the Board on Baby Land Headstone Project and stated Mr. Jeff Jones will be installing the headstones on April 15. Only three families responded of the nine that were notified.

The Board suggested staff to make some modifications to the Cemetery Waiver Form before approval.
