#### 1. Call to Order

Becky Kauffman called the meeting to order at 5:45 p.m.

#### 2. Approve minutes of meetings held May 9 and May 17, 2019

#### 3. Conduct workshop on preservation topics including Hardy-Heck-Moore Zone 1 survey

Anita presented the photos of 206 E. Marvin to get the Commission's feedback on recent changes. Railing still inappropriate. Anita will notify the owner.

Anita told the board about the recently passed legislation concerning designation of historic landmarks by municipalities—HB 2496—and how her colleagues from around the state are interpreting it. There was some discussion.

Anita provided information obtained at CAMP training and some follow up research she had done on resources that might be beneficial to the Commission. There was some discussion.

Becky introduced the information from the Hardy-Heck-Moore downtown survey and the group went down the list of each property. Each property was discussed and it was decided that the Commission should send letters to the owners of those listed as high priority and recommended for local designation. Anita will draft a letter to owners of these properties notifying them that the Commission would like to designate their property as a local landmark.

Louis Brown told the board that he was retiring from the HPC. Anita provided information on who has submitted applications to serve on the board. Appointments will be made by the city council in September. There was some discussion and Anita was directed to contact one of the applicants for more information.

Anita told the board about the confusion regarding Oldham Street/Avenue. There was some discussion and Shannon Simpson said he would look at old city directories to see if/when that might have changed.
