## 5. Hear report on cemetery activities and take any necessary action

Mr. Smith introduced Mr. Gumaro Martinez, Assistant Parks and Recreation Director, noting he will be taking over as Cemetery Sexton and begin training in January.

Mr. Smith reported on the following activities:

- Sold eight spaces and held nine services in September
- Sold seven spaces and held ten services in October
- Adding two full time employees at the Cemetery
- The pavilion project is ready to go out for bid

Ms. Connie McGuire inquired about the cemetery expansion and Mr. Smith explained the land is purchased and money is budgeted to clear the land. Mr. Perry Giles inquired about adding a public restroom and Mr. Smith noted there is a sewer line to the site and that is a strong possibility. He

noted the prefabricated bathrooms that have been installed at the city parks have worked well and our durable.

Mr. Smith discussed cemetery projects and presented an estimate to replace the fencing and signage at the front entrance to match the entrance of Addition 12.

The board discussed the following concerns:

- High sign to allow for large trucks and equipment to drive through
- Deterioration of Veterans' monument
- Issue with nutgrass and grass burs in the cemetery

Mr. Smith explained he will obtain more quotes for the new entryway design and construction and will reach out to someone about monument preservation and reconstruction.

Ms. McGuire inquired about the tree-planting program and Mr. Smith explained the Keep Waxahachie Beautiful Committee is working on that project and will keep the cemetery in mind.
