17. Consider approving an agreement to contribute right-of-way funds (fixed price) for FM 664 ROW acquisition between the City of Waxahachie and Texas Department of Transportation (TxDOT) and approve associated supplemental appropriation in the amount of \$136,206.74

Director of Public Works and Engineering James Gaertner requested approval of an agreement with Texas Department of Transportation (TxDOT) for the City portion of the Right-of-Way (ROW) acquisition associated with the FM 664 widening project. He explained the total amount of the city participation for ROW acquisition is \$744,389.70, which amounts to \$136,206.74 for

FY 2021-2022 and \$152,045.74 for each of the following four years. Mr. Gaertner requested approval of a supplemental appropriation for \$136,206.74 for FY 2021-2022 and authorize the City Manager to sign the TxDOT agreement.

Mayor Hill noted the expansion of FM 664 will begin in approximately four years.

Council Member Billie Wallace moved to approve an agreement to contribute right-of-way funds (fixed price) for FM 664 ROW acquisition between the City of Waxahachie and Texas Department of Transportation (TxDOT) and approve associated supplemental appropriation in the amount of \$136,206.74. Council Member Travis Smith seconded, All Ayes.

18. Consider a supplemental appropriation in the amount of \$27,000 for a visual building envelope assessment

Director of Administrative Services Richard Abernethy requested approval of a supplemental appropriation in the amount of \$27,000 for a visual building envelope assessment which will include an assessment of existing roof systems, windows, cladding and associated exterior elements to identify areas needing repairs or mitigation.

Council Member Billie Wallace moved to approve a supplemental appropriation in the amount of \$27,000 for a visual building envelope assessment. Council Member Patrick Souter seconded, All Ayes.

Council Member Smith expressed the importance of having procedures in place for naming public facilities and thanked Mayor Hill for getting the item on the agenda. He encouraged City Council members to perform due diligence when considering naming public facilities. He applauded City staff and City Attorney Robert Brown for working with City Council to prepare the resolution.

Council Member Souter noted the resolution is a framework for naming eligible facilities. He recognized the possibility of creating a citizen committee if the need arises. He stated current and future Council members have the responsibility to perform due diligence.

There being no others to speak for or against the proposed Resolution adopting procedures to name public facilities, Mayor Hill closed the Public Hearing.

1. Call to Order

Mayor David Hill called the meeting to order.

2. Conduct a briefing to discuss items for the 7:00 p.m. regular meeting

Deputy City Manager Albert Lawrence reviewed the following agenda items:

- Item 5e, approving event application for Diving Deeper VBS Day Camp to be held on July 27, 2022.
- Item 5f, approving event application for Lippert 5K to be held on August 20, 2022.
- Item 5g, approving an interlocal agreement with Frisco ISD to allow for the City to utilize Frisco ISD's cooperative purchasing agreement.
- Item 5h, approving City Council appointments to boards and commissions.
- Item 19, proposed Resolution adopting procedures to name public facilities.

City Attorney Robert Brown noted the resolution serves as guidelines for naming public facilities and the City Council retains absolute discretion to deny a naming request or to name an eligible City-owned facility to a name of the Council's choosing.

Council Member Billie Wallace expressed concern that a citizens' input committee and background check are not included in the resolution. Mr. Brown responded that nothing in the resolution would prohibit a citizen committee or background check, but does not require it.

Council Member Chris Wright stated he does not believe a citizen committee is a necessary requirement as the City Council was elected by the citizens and citizens are able to participate during a Public Hearing prior to Council vote.

Council Member Patrick Souter stated he opposes a requirement for a citizen committee for the purpose of vetting a person and serving as a recommending body before a City-owned facility can be considered by the Council. Council Member Souter stated it is the Council's responsibility to

perform due diligence to protect and act in the best interest of the city. Council Member Souter expressed opposition to a required background check, as he does not want to disqualify someone for a past infraction that does not include moral turpitude and has been a great asset to the city.

Director of Public Works and Engineering James Gaertner reviewed Item 17 requesting approval of an agreement with Texas Department of Transportation (TxDOT) for the City portion of the Right-of-Way (ROW) acquisition associated with the FM 664 widening project. He explained the total amount of the city participation for ROW acquisition is \$744,389.70, which amounts to \$136,206.74 for FY 2021-2022 and \$152,045.74 for each of the following four years. Mr. Gaertner requested approval of a supplemental appropriation for \$136,206.74 for FY 2021-2022 and authorize the City Manager to sign the TxDOT agreement.

Director of Administrative Services Richard Abernethy reviewed Item 18 requesting approval of a supplemental appropriation in the amount of \$27,000 for a visual building envelope assessment which will include an assessment of existing roof systems, windows, cladding and associated exterior elements to identify areas needing repairs or mitigation.

Jennifer Pruitt, Senior Director of Planning, reviewed the following cases:

- ZDC-45-2022, the applicant is requesting to add a 72 square foot (6 ft. x 12 ft.) electronic message sign to an existing pole sign for the Cowboy Baptist Church located at 2374 W US Highway 287 Bypass. Ms. Pruitt stated the pastor of Cowboy Baptist Church met with the Planning Department and provided additional details including confirmation of sign height at 15 feet per P&Z Commission and the existing sign is within an easement. The applicant will also encase the pole in a pole covering. Ms. Pruitt noted staff recommends approval as presented.
- SUB-28-2022, the applicant is proposing to replat the subject properties into six (6) lots for residential use. Ms. Pruitt noted the applicant made a Petition of Relief Waiver request. As part of the Petition of Relief Waiver, the applicant is requesting a variance to allow for a reduced utility easement of 8 ft. along the Cynisca Street and Floyd Street frontage, with the standard 15 ft. utility easement along Olive Street. Ms. Pruitt noted staff recommends approval as presented.
- SUB-60-2022, the applicant is requesting to replat the subject property into one (1) lot for single-family residential use. The applicant is also requesting a Petition of Relief Waiver for a right-of-way (ROW) and utility easement dedication along Henry Street. The Petition of Relief Waiver includes a variance request for the standard 15 ft. utility easement along Henry Street and requests to provide a 10 ft. utility easement along Henry Street. Ms. Pruitt noted staff recommends approval per conditions.
- SUB-15-2022, the applicant is proposing to plat approximately 10.67 acres to create three (3) lots including one lot for open space, the second lot for mixed use, and the third lot for a commercial lot. Ms. Pruitt noted the proposed plat is in conformance with the previously approved Planned Development for the area. The applicant is requesting a variance to reduce the utility easement along North Grove Boulevard and Washington Avenue from 15 feet to 10 feet. Ms. Pruitt stated the applicant has secured sign off letters from the affected utilities regarding the variance request. Ms. Pruitt noted staff recommends approval per staff comments.

• ZDC-54-2022, the applicant is requesting approval of a Planned Development District with a base zoning of Central Area District to allow for a tattoo shop at 212 S. Rogers Street. Ms. Pruitt noted, if approved, staff recommends the applicant comply with provisions including the tattoo shop may occupy up to 800 square feet of the first floor building area within Heart-In-Hand, the tattoo shop may operate from 10:00 am – 10:00 pm Wednesday through Saturday, the tattoo shop shall require a license by the Texas Department of State Health Services at all times, and all exterior signage shall require a sign permit from the Building Department and Historic Preservation Committee approval. Staff recommends approval per staff comments.

Council Member Travis Smith stated if approved, the tattoo shop will be maintained and operated by world-renowned tattoo artist Mr. Oliver Peck. The tattoo shop will also bring additional funding to the Odd Fellows Lodge. Council Member Souter inquired about sign design. Council Member Smith replied that the sign will be a simple hanging sign on Jefferson St.



THIS INTERLOCAL COOPERATIVE PURCHASING AGREEMENT (the "Agreement") is made on the 18th day of July, 2022, between the City of Denton, and City of Waxahachie; jointly referred to herein as "parties" and each separately as a "party."

WHEREAS, each party is authorized by Chapter 791 of the Texas Government Code (the "Interlocal Cooperation Act"), to enter into joint contracts and agreements for the performance of governmental functions and services including administrative functions normally associated with the operation of government such as purchasing necessary materials and supplies;

WHEREAS, Section 271.102 of the Texas Local Government Code authorizes a local government to participate in a cooperative purchasing program with another local government or a local cooperative organization;

WHEREAS, the parties recognize that participation in this cooperative purchasing program will be highly beneficial to the taxpayers of the parties through anticipated savings to be realized;

WHEREAS, the parties cannot normally obtain the best possible purchase price for materials and supplies acting individually and without cooperation;

WHEREAS, it is deemed in the best interest of all parties that said governments enter into a mutually satisfactory agreement for the purchase of certain materials and supplies; and

WHEREAS, the parties, in performing governmental functions or in paying for the performance of governmental functions hereunder, shall make that performance or those payments from current revenues legally available to that party;

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants and conditions contained herein and pursuant to the authority permitted under the Interlocal Cooperation Act, promise and agree as follows:

I.

Purpose

A. The purpose of this Agreement is to establish a cooperative purchasing program between the parties, which will allow each party to purchase goods and services under each other's competitively bid contracts pursuant to Subchapter F, Chapter 271 of the Texas Local Government Code.

II. Duration of Agreement

- A. This Agreement shall be in full force and effect from the date it is duly executed by all parties until terminated by either party to this Agreement. Any party may modify and/or terminate this Agreement in accordance with the following terms and conditions:
 - The terms and conditions of this Agreement may be modified upon the mutual consent of all parties. Mutual consent will be demonstrated by approval of the governing body of each party hereto. No modification to this Agreement shall be effective and binding unless and until it is reduced to writing and signed by duly authorized representatives of all parties.
 - This Agreement may be terminated at any time by either party, with or without cause, upon thirty days' written notice to the other party. Unless otherwise specified, written notice shall be deemed to have been duly served if delivered in person, sent (i) as an attachment to an email, (ii) by fax with a successful send confirmation, or (iii) by certified mail to the address as listed herein:

III. Relationship of Parties

A. It is agreed that the parties, in receiving products and/or services specified in this Agreement, shall each act as an independent purchaser and shall have control of its needs and the way any such products and/or services are acquired. Neither party is an agent, employee or joint enterprise of the other, and each party is responsible for its own actions, forbearance, negligence and deeds, and for those of its agents or employees, in conjunction with the

utilization and/or cooperative solicitation of any supplier agreement obtained in accordance with Texas law.

- B. The parties shall notify, using the notice procedures set forth in Section II.A, all participating entities of available contracts to include terms of contract, commodity cost, contact names and addresses, and shall keep participating parties informed of all changes to the list of contracts available for cooperative purchasing.
- C. Each party shall ensure that all applicable laws and ordinances have been satisfied with respect to any action taken by such party pursuant to this Agreement.
- D. Nothing in this Agreement shall prevent any participating party from accepting and awarding bids for commodities subject to this Agreement individually and on its own behalf.
- E. Purchasing Agent or their designee, is the official representative to act for the City of Denton in all matters relating to this Agreement.
- F. Purchasing Manager or their designee, is the official representative to act for City of Waxahachie in all matters relating to this Agreement.

IV. Purchase of Goods and Services

- A. All products and services shall be procured in accordance with all appropriate procedures governing competitive bids and competitive proposals, as required by the laws of the State of Texas.
- B. The parties will be able to purchase from those contracts established by the other party where notice has been given in the bid specifications and the successful bidder has accepted terms for cooperative purchasing agreements for local governments.
- C. The parties hereto agree that the ordering of products and services through this Agreement shall be their individual responsibility and that the successful bidder or bidders shall bill each party directly or, if deemed advantageous by the parties, to both parties.
- D. The parties agree to pay successful bidders directly for all products or services received from current revenues available for such purchase. Each party shall be liable to the successful bidder only for products and services ordered by and received by such party and shall not, by the execution of this Agreement, assume any additional liability.
- E. The parties do not warrant and are not responsible for the quality or delivery of products or services from the successful bidder. The participating parties shall receive all warranties provided by the successful bidder for the products or services purchased.

F. If any dispute arises between individual parties and a successful bidder, such dispute shall be handled by and between the participating party's governmental body and the bidder.

V.

Liability and Immunity Provisions

- A. It is understood and agreed between the parties that each party hereto shall be responsible for its own and its employees' acts of negligence in connection with this Agreement. Neither party shall be responsible for any negligent act or omission of the other party or its employees in connection with this Agreement. It is specifically agreed that, as between the parties, each party to this Agreement shall be individually and respectively responsible for responding to, dealing with, insuring against, defending, and otherwise handling and managing liability and potential liability of itself and its employees pursuant to this Agreement.
- B. Notwithstanding the foregoing, each party hereto reserves and expressly does not waive any immunity or defense available at law or in equity, including governmental immunity, for any claim or cause of action whatsoever that may arise or result from the services provided and/or any circumstances arising under this Agreement. These provisions are solely for the benefit of the parties hereto and are not for the benefit of any person or entity not a party hereto; this Agreement shall not be interpreted nor construed to give any claim or cause of action arising pursuant to or out of the services provided under this Agreement, except as specifically provided by law. Where injury or property damages results from the joint or concurrent negligence of both parties, liability, if any, shall be shared by each party based on comparative responsibility in accordance with the applicable laws of the State of Texas, subject to all defenses available to them, including governmental immunity.
- C. This Agreement is expressly made subject to the parties' governmental immunity under the Texas Civil Practice and Remedies Code and all applicable federal, state, and local laws, rules, regulations, ordinances, and policies. Nothing in this Agreement shall be deemed to waive, modify, or amend any legal defense available at law or in equity to either party or to create any legal rights or claim on behalf of any third party. Neither party waive, modify, or alter, to any extent whatsoever, the availability of the defense of governmental immunity under the laws of the State of Texas.

VI.

Miscellaneous

- A. Each party has the full power and authority to enter into and perform this Agreement and the person signing this Agreement on behalf of each party has been properly authorized and empowered to enter into this Agreement. The persons executing this Agreement hereby represent that they have authorization to sign on behalf of their respective party.
- B. In the event any one or more of the provisions contained in this Agreement shall be held, for any reason, to be invalid, illegal, or unenforceable in any respect, such invalidity, illegality,



or unenforceability shall not affect the other provisions and the Agreement shall be construed as if such invalid, illegal, or unenforceable provision had never been contained in this Agreement.

- C. This Agreement shall be binding upon the parties hereto, their successors, heirs, personal representatives, and assigns. Neither party will assign or transfer an interest in this Agreement without the prior written consent of the other party.
- D. By entering into this Agreement, the parties do not create any obligations, express or implied, other than those set forth herein, and this Agreement shall not create any rights in, or claims by, third parties who are not signatories to this Agreement.
- E. This Agreement shall be interpreted in accordance with the laws of the State of Texas and venue of any cause of action concerning this Agreement shall be in a court of competent jurisdiction sitting in Denton County, Texas.
- F. This Agreement, together with any referenced exhibits and attachments, constitutes the entire agreement between the parties hereto, and any prior agreement, assertion, statement, understanding, or other commitment occurring during the term of this Agreement, or subsequent thereto, has no legal force or effect whatsoever, unless properly executed in writing in accordance with Section II.A, and if appropriate, recorded as an amendment of this Agreement.
- G. Failure of any party, at any time, to enforce a provision of this Agreement, shall in no way constitute a waiver of that provision nor in any way affect the validity of this Agreement or the right of either party thereafter to enforce each provision hereof. No term of this Agreement shall be deemed waived or any breach excused unless the waiver shall be in writing and signed by the party claimed to have waived. Furthermore, any consent to or waiver of a breach will not constitute consent to or waiver or excuse of any other different or subsequent breach.
- H. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original and constitute one and the same instrument.
- I. To the extent allowed by law, each party agrees to release, defend, indemnify, and hold harmless the other (and its officers, agents, and employees) from and against all claims or causes of action for injuries (including death), property damages (including loss of use), and any other losses, demands, suits, judgments and costs, including reasonable attorneys' fees and expenses, in any way arising out of, related to, or resulting from its performance under this agreement, or caused by its negligent acts or omissions (or those of its respective officers, agents, employees, or any other third parties for whom it is legally responsible) in connection with performing this agreement.

8 The laws of the State of Texas shall govern the interpretation, validity, performance and enforcement of this Agreement.

9. The provisions of this Agreement are severable. If any paragraph, section, subdivision, sentence, clause, or phrase of this Agreement is for any reason held by a court of competent jurisdiction to be contrary to law or contrary to any rule or regulation having the force and effect of the law, the remaining portions of the Agreement shall be enforced as if the invalid provision had never been included.

10. This Agreement embodies the entire agreement between the parties and may only be modified in writing executed by both parties.

11. This Agreement shall be binding upon the parties hereto, their successors, heirs, personal representatives and assigns. Neither party will assign or transfer an interest in this Agreement without the written consent of the other party.

12. It is expressly understood and agreed that, in the execution of this Agreement, neither party waives, nor shall be deemed hereby to have waived any immunity or defense that would otherwise be available to it against claims arising in the exercise of governmental powers and functions. By entering into this Agreement, the parties do not create any obligations, express or implied other that those set forth herein, and this Agreement shall not create any rights in parties not signatories hereto.

13. The declarations, determinations and findings declared, made and found in the preamble to this Agreement are hereby adopted, restated and made part of the operative provisions hereof.

Re: Budget Amendment for Robert W. Sokoll Water Treatment Plant

Item Description: A Budget Amendment request to increase the expenditures budget for the supplies and equipment treatment chemicals line item account 512 726-56108 in the amount of \$65,000.

Item Summary: This budget amendment will provide additional funds for purchasing treatment chemicals at the Robert W. Sokoll Water Treatment Plant for the remainder of the fiscal year. Staff budgeted to treat an anticipated 3.4 million gallons per day (MGD) average for fiscal year 2022. This amount includes both Waxahachie and Rockett SUD usage. Lack of rainfall and warmer early summer temperatures have caused a higher than normal water demand. To date the daily treated raw water average at the Sokoll Plant has been 4.2 MGD. The water treatment chemical supply industry have also seen an increase in manufacturing costs related to fuel prices and ongoing supply chain issues. In May 2022 the Utilities department accepted a mid-year price increase from chemical suppliers to offset supplier's manufacturing costs, thus creating additional unforeseen chemical expenses.

Fiscal Impact: The total amount of the budget amendment increase is \$65,000. Staff is requesting approval of this Budget Amendment for \$65,000.

Item Description: Supplemental Appropriation for City Hall Annex Guaranteed Maximum Price contract and associated change orders in the amount of \$2,923,074

Item Summary: On August 16, 2021, the City Council approved an Initial Guaranteed Maximum Price (IGMP) for a total amount \$14,500,000. This was an initial budget to allow the City to move forward with authorizing the necessary bid packages that were associated with each stage of the construction project. A total of \$7,5000,00 was included in the FY 20-21 bond package and another \$7,000,000 was included in the FY 21-22 operational and maintenance budget. After all bid packages were received the Final Guaranteed Maximum Price (GMP) amount was \$14,799,060. In addition to the IGMP cost, the City also incurred expenses for materials testing and survey costs for easements. As the result the total amount needed for the Final GMP is \$344,000.

In addition, the initial construction plans and budget did not include finishing out the third floor of the City Hall Annex and providing for space for the Chamber of Commerce as well as flex space through the finish out of the Retail Building. And with continued increases in construction costs, the City can take advantage of finishing out the flex spaces now instead of waiting till later when costs will be much higher. These spaces are anticipated to accommodate staff during the remodel of the City Hall project. The total change order amount with Steele and Freeman (SFI) for this work is \$2,359,659.

There are also some additional costs associated with retaining walls, electrical items, ductwork and associated architectural fees totaling \$219,415.86.

Staff recommends approval of this supplemental appropriation, the Final GMP and associated change orders with SFI to complete the funding requirements to finish out the Annex building, to provide needed flex space, and prepare the tenant lease space.

Fiscal Impact: The proposed supplemental appropriation in the amount of \$2,923,074 would be funded from the General Fund unrestrictive reserve balance.

Item Description: Supplemental Appropriation for Furniture, Fixtures and Equipment in the amount of \$1,353,146

Item Summary: On August 16, 2021, the City Council approved an Initial Guaranteed Maximum Price (IGMP) to allow the City to move forward with authorizing the necessary bid packages that were associated with each stage of the Annex construction project. At that time, staff anticipated appearing before City Council this fiscal year to request an additional authorization for expenditures associated with furniture, fixture equipment and technology for approximately \$1,500,000.

Since then, staff has been working with the project manager and the Information Technology Department to identify furniture and equipment needs. After thorough review, staff is recommending moving forward with SKG to supply the furniture for the City Hall Annex in the amount of \$797,118. The furniture product is Herman Knoll will be purchased through a purchasing cooperative. The furniture selected will meet both the current and future needs of staff in the building.

In addition, staff also looked at the best way to procure the technology components of the building. This equipment includes low voltage cabling, access controls, CCTV cameras, and audio/visual systems. After thorough review, staff determined having Steele and Freeman (SFI) bid out the technology as part of

the overall construction project would allow the City to get the best competitive pricing. After receiving bids and going through the value engineering review, the total change order amount with SFI is \$556,028

The overall cost is below the anticipated budget and these purchases will allow staff to move forward with the procurement and installation of furniture and technology for the Annex building. Staff recommends approval of the supplemental appropriation as well as the SKG contract and change order with SFI associated with technology.

Fiscal Impact: The proposed supplemental appropriation in the amount of \$1,353,146 would be funded from the General Fund unrestrictive reserve balance.

Our firm has been asked to undertake a tax exempt financing in the amount of \$2,800,000 for the benefit of Southwestern Assemblies of God University ("SAGU"). The project to be financed is improvements to SAGU's track and field, soccer and football fields, all to be located on the university campus at 1200 Sycamore in Waxahachie. This debt is <u>not</u> a debt of the City of Waxahachie in any manner whatsoever. Citizens National Bank of Texas has agreed to make the loan and SAGU will have sole liability to repay it.

The tax exempt debt will be issued by the Oglesby Education Facilities Corporation.

Under Section 147(f) of the Internal Revenue Code, for this to be a tax exempt loan we are required to get the approval of both Waxahachie (where the project is to be located) and the City of Oglesby (which is where the debt will be "issued").

We go to little towns like Oglesby because there is an advantage to issue the financing through a small city which will not issue more than \$10,000,000 in tax exempt financing for all purposes during 2022.

WHEREAS, Southwestern Assemblies of God University ("SAGU") desires to enter a tax exempt loan transaction in the amount of \$2,800,000 through the Oglesby Education Facilities Corporation to finance the following facilities:

improvements to SAGU's track and field, soccer, and football fields (together, the "Project"), with such facilities being located on the SAGU campus; located at 1200 Sycamore, Waxahachie, Texas 75165; and

WHEREAS, the proposed financing imposes no liability of any kind on the City of Waxahachie, Texas (the "City") and the City is being asked to give its approval of the financing and the Project solely to satisfy a provision in Section 147(f) of the Internal Revenue Code (which provides that this transaction must be approved by the jurisdiction in which the SAGU Project is located); and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WAXAHACHIE, TEXAS:

1. That the above recitals are true and correct.

2. That this City Council hereby approves the SAGU Project, the ownership and operation of the Project by SAGU; the location of the Project; and a tax exempt financing by the Oglesby Education Facilities Corporation in the amount of \$2,800,000 (to be purchased by Citizens National Bank of Texas) to finance the Project.
