## 3. Approve minutes of meeting held December 8, 2022

4. Consider final approval of Certificate of Appropriateness for 112-114 E. Main, consider approval of HT tax exemption for that property, approve submission of grant application to Historic Waxahachie, Inc.

Anita went over the information in the packet and explained that Mr. Gallo needed final approval in order to apply for the HWI façade grant. Work was completed according to the Commission's instructions and the doors were the reason for denial of the property for the HT exemption. If work is approved, property should be eligible to receive exemption. Glinda Felty made a motion to approve the COA for 112-114 E.
