7. Discuss investment consultant search and meet Tony Kay, AndCo Consulting

The following information was provided by Tony Kay, AndCo Consulting:

- Tony Kay is based in Dallas
- AndCo Consulting offers trustee education
- AndCo Consulting opened in 2000 and was built around providing resources and customer service
- AndCo Consulting has seven (7) TLFFRA accounts including Killeen, Beaumont, and Wichita Falls all 10-year accounts.
- Revenue is earned through fee structure, not incentives or returns
- 44% of AndCo Consulting clients are the size of Waxahachie or smaller
- AndCo Consulting recommends indexing large cap domestic, move to private RE manager over Baron REIT, and replace MLP as fixed income
- AndCo Consulting provides Peer Universe Rank (WFR vs other TLFFRA)
- AndCo Consulting recommends refining IPS
- AndCo Consulting believes 7% return is attainable
- AndCo Consulting has a \$30,000 fee. Raises are typically based on inflation percentage.
