ORDINANCE NO. 2760

AN ORDINANCE OF THE CITY OF WAXAHACHIE, TEXAS, CREATING THE KEEP WAXAHACHIE BEAUTIFUL COMMITTEE FOR THE CITY OF WAXAHACHIE TEXAS, AND SETTING AN EFFECTIVE DATE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WAXAHACHIE:

WHEREAS, the City Council hereby establishes a Committee to be known as Keep Waxahachie Beautiful.

WHEREAS, the Keep Waxahachie Beautiful Committee shall serve the needs of the city and residents of Waxahachie, Texas, by supporting the efforts of Keep Waxahachie Beautiful, an organization whose purpose is to enhance the community through beautification, litter prevention and waste reduction.

WHEREAS, the City of Waxahachie adopted the affiliate chapter in 2014 and has thenceforth assumed all responsibility as affiliate coordinator, including project coordination, volunteer management, public relations, financial support, and reporting to primary affiliate, Keep Texas Beautiful.

WHEREAS, the Keep Waxahachie Beautiful Committee was formed to have a citizen-based authority to assist in setting goals, prioritizing projects and serving as a liaison between the city and community.

NOW, THEREFORE, this committee is governed by the by-laws adopted upon passage of this ordinance in Exhibit A.

KEEP WAXAHACHIE BEAUTIFUL COMMITTEE BY-LAWS

Adopted September 15, 2014

ARTICLE I

Name

The name of this organization shall be Keep Waxahachie Beautiful Committee, located in Waxahachie, Ellis County, Texas.

ARTICLE II

Purpose

Keep Waxahachie Beautiful Committee shall serve the needs of the city and residents of Waxahachie, Texas, by supporting the efforts of Keep Waxahachie Beautiful, an organization with the purpose of enchancing the community through beautification, litter prevention and waste reduction.

ARTICLE III

Origin

Keep Waxahachie Beautiful a non-profit organization established through the Waxahachie Chamber of Commerce in the year 1988. The City of Waxahachie adopted the affiliate chapter in 2014 and has thenceforth assumed all responsibility as affiliate coordinator, including project coordination, volunteer management, public relations, financial support, and reporting to primary affiliate, Keep Texas Beautiful. The Keep Waxahachie Beautiful Committee was formed to have a citizen-based authority to assist in setting goals, prioritizing projects and serving as a liaison between the city and community, and was created by Ordinance No. 2760.

ARTICLE IV

Policy

The policy of the Keep Waxahachie Beautiful Committee shall be to promote the aforesaid purpose without regard to race, color, sex, origin.

ARTICLE V

Function of the Committee

The Committee Shall:

1. Set basic policies

- 2. Review the needs of Keep Waxahachie Beautiful chapter and set goals to accomplish
- 3. Approve projects
- 4. Enlist community support
- 5. Assist in raising funds and pursuing grants for necessary projects

ARTICLE VI

Membership of the Committee

The Committee shall be made up of seven (7) members interested in helping to beautify Waxahachie through community service projects. Committee members shall serve for a term of three (3) years, with the exception that for the inaugural Committee, the City Council shall appoint four (4) members of the voting members to a term of four (4) years and three (3) of the voting members to a term of three (3) years. There shall be one (1) ex-officio member who represents the Waxahachie Chamber of Commerce. The Committee shall be organized by electing one chairman and one vice-chairman. The officers of said Committee shall serve for one year and until their successors are elected and qualified. This provision shall not operate so as to extend the term of any Committee member.

ARTICLE VII

Meetings

The Committee shall meet as needed on a date chosen by the Committee. The staff liaison shall notify members prior to each meeting. One (1) more than half (1/2) of the Committee members shall constitute a quorum; however all Committee members are responsible for attending Committee Meetings regularly. Two (2) absences without prior notice or three (3) absences total (yearly) from the Committee Meetings shall be deemed a resignation from the Committee.

ARTICLE VIII

Parliamentary

The rules contained in Robert's Rule of Order (latest version) shall govern the organization in all cases to which they are applicable and in which they are no inconsistent with these by law.

ARTICLE IX

Amendments

These bylaws may be amended by a 2/3 vote of the Committee Members present, provided a quorum is present and the proposed amendments were read at the preceding meeting.
