# 11. Present Council with Texas Travel Industry Association Best of Texas Award – "Best City" during the 2017 Texas Study Tour

Ms. Laurie Mosley, Director of Convention and Visitors Bureau, presented the City Council with the Texas Travel Industry Association Best of Texas Award for Best City during the 2017 Texas Study Tour. She stated the CVB had approximately 3 hours to show them Waxahachie and with the help of several merchants and others, the Travel Industry Association had a great experience.

# 12. Recognition of National Tourism Week – May 6 – 12, 2018

Ms. Mosley recognized May 6 - 12, 2018 as National Tourism Week noting the week celebrates the economic boost that tourism provides around the country and to our region. She provided the following information of the economic impact of tourism in Waxahachie for calendar year 2016:

- \$59 million dollars were spent in Waxahachie by tourists
- Directly provided 490 jobs with an annual payroll of \$18 million
- Waxahachie, through tourism, contributed over \$1.7 million in local taxes and over \$3.8 million in state taxes
